We appreciated the presence of all our invited guests throughout our Council meeting: Rawle Andrews Esq (Executive Director APA Foundation), Dr Ray Hsaio (Assembly Recorder), Dr Ken Certa (BOT Parliamentarian), Dr Clarence Chou (APAPAC Board Chair), Dr Geetha Jayaram (Area 3Trustee), Dr Donna Norris (Past Speaker), Dr Theresa Miskimen (APA President Elect), Ms Kristin Kroeger (Division Chief, Advocacy, Policy and Practice Advancement), Ms Robin Levy (Regional Director, State Government Relations), and Ms Jennifer Medicus (APA Area 3 Liaison and Practice Guidelines Deputy Director).

Dr Dunlap shared a reflection on why we meet as an Area – to learn about the Area 3 District Branches work, challenges, efforts; to have a shared vision and implement the strategic vision of the APA; to seek input from the District Branches that supports the liaison and bi-/multi-directional communication between the District Branch membership, the Assembly, the AEC and BOT. She emphasized that elected members of Area 3 Council have the privilege and responsibility to actively participate.

Assembly Executive Committee (AEC) highlights reviewed; refer to the AEC Report completed by Allison Moraske and shared in the packet. A workgroup will be reviewing the vote by strength and overall representation of APA membership at the Assembly (related to the Action Papers 12Q and 12R passed at the May 2024 Assembly). The work group will be looking at both items and work with the Procedures Committee with a recommendation for the Assembly. There was some discussion related to concerns about why as a representative body would we try to limit representation. Additional themes included the importance of our Area 3 representation and voting strength. Our votes have an impact! It was emphasized and encouraged if a representative is unable to attend an Area 3 Council Meeting or the Assembly to work with your district branch leadership and process to identify a proxy delegate to represent you. This has an effect to expose those members who may want to increase their involvement in the organization. There was active discussion of the basics of representation at the Assembly, an egalitarian approach to seating, parliamentary procedures (requests/efforts to clarify meaning/impact of motions) - NOTE: at the back of the Assembly Handbook there is a "Guide to Parliamentary Motions".

There was discussion regarding the Communities Platform and a request to better understand its potential functions to help with communication. There was a plan to

follow up with Stephanie Keuser (Chief, Information Technology) and Lisa Diener (Managing Director).

Treasurer's report: reviewed the budget process for this year; discussed the challenges for the budget; difficulties in understanding the market forces in the next several years and impact to the APA revenue streams; responsibility to APA Climate footprint; the opportunity for Drs. Dunlap and Albaugh to meet with Dr Steven Starks to share Area 3 wish list relative to the Assembly Budget – funding for the current support of Area 3 historical website until an alternative plan is determined (~\$300-400/year), funding for Area 3 RFM Awards, supporting in person Assembly meetings 2x yearly and an in person Area 3 meeting. Budget and Finance Committee will be meeting soon.

## Updates/Report shared covering:

- the Continuing Resolution process/status, the potential role for end of the year Health package that could include APA priorities
- telehealth supporting a 2 year extension
- Complete Care Act to increase reimbursement to CoCM codes passed the Senate and now in discussion in the House Committee
- GME Bipartisan effort to increase GME slots with focus on rural areas and areas of need
- Prior Authorization bipartisan supported but not moved or attached to a bill
- Advocacy priorities: GME, Prior Auth, increased funding for CoCM codes and Telehealth
- Reviewed the press release for Parity; with the Chevron Document overturned, there are increased vulnerabilities potentially to the Rules process— major concerns; there is an ask for 2 year extension for flexibilities for telehealth for time to review the rule; Concerns that the DEA plan will be more stringent (increasing the expectations for in person visits); HHS doesn't support the current DEA rule-not sufficient time for practices to pivot
- Billing codes for telehealth discussion/impact to practice, to the provision for supervising residents, use of office address when delivering telehealth from home
- CMS paying for services via digital apps (APA not supportive currently due to not sufficient efficacy/evidence)
- Medicare fee schedule APA partnering with AMA/colleagues in medicine – asking for Congress to come together to stop cuts and develop formula for steady funding
- Stimulant shortage discussion; support increased production for stimulants and a need to understand the complexities as to why this is happening (noting a cyclical pattern); APA sent out a survey
   Area 3 members provided input

 State Advocacy Conference – anticipated to have 150 attendees (at capacity!) – topics on the agenda: RxP, Scope, supervision of NP and PA team members, psychedelics panel, Fed-State MH Parity

BOT Update: Geetha Jayaram highlighted area of concern and focus at the BOT

- Nominating committee challenges with volunteers
- Membership is a PRIORITY
- Discussion of budgetary and operational discipline
- Guidelines development and reviews discussion Jennifer Medicus presented to her division on basics for guideline development

- Impact/effects (positive/negative) of Social Media research/active work; how do we use AI, social media platforms and telehealth; changing curricula at training programs

President-elect Theresa Miskimen – Welcomed to Area 3 Council meeting – "Area 3 is where my heart lies" { <a href="mailto:tmiskimen@psych.org">tmiskimen@psych.org</a> }

Dr Miskimen is the JRC Chair. She reviewed the formalized process for nominations for Councils and Committees. Applications are accepted at the APA website (opened 9/1/24 and will close on 11/8/24); She encouraged members spread the word at their DBs to review the councils/committee opportunities and where the person's expertise could best share/serve and then apply. Appointments will be reported to the BOT in March 2025 and once approved will be effective May 2025. There are 14 Councils and 16 Committees in the Council with the goal to decrease the "silo" experience and increase communication and collaboration, highlighting the future

planning for voice of members – inter-council collaboration for coordinated operations and elevation of the work.

Area 3 Council Reports (DB, ACORF, ACROSS, ECP, M/UR)

District Branch Reports are in the packet and in the final section of these minutes is a list/posting of upcoming meetings and events.

Narpinder Malhi, member of the IMG Caucus and the M/UR Chair on the AEC shared updates with IMG supports. Additionally there was discussion relative to the Action Paper authored by Jessica Isom and passed at the Assembly in 2021 – supporting a name change for Minority/Underrepresented Groups (M/UR) and the active efforts with a survey and determining next steps. There are currently 3 names being considered:

- DHM = Diverse and Historically Marginalized
- EQUATE = Equity, Anti-racism. Transformational, Empowerment
- JEDI = Justice, Equity, Diversity and Inclusion Committee

Dr. Dunlap raised concerns – she acknowledged this process and determination represent a very important decision; she is concerned about making sure that the discussion includes a full representation of voices. Drs Dunlap and Malhi will connect after the meeting to follow up on the process/decision making.

Hector Colon-Rivera shared update for the APA Hispanic Caucus. There is an exhibition starting on Tuesday. The exhibition will spotlight the Task Force on Mental Health of Spanish Speaking People in the US which was established in 1970, the Committee of Hispanic Psychiatrists which was established in 1976 and past Simon Bolivar Lecture recipients.

Dr. Aggarwahl, Chair of the Council on Medical Education and Lifelong Learning (CML) provided updates on resident and medical student awards as well as reviewing position statements and action papers. 2 areas of focus 1) Al and Education; workshops at the APA and 2) Workforce issues – lens of education and preparation of residents.

Clarence Chou, Chair of APAPAC Board was welcomed. He discussed his work with the Workgroup on meetings – tackling meetings/climate impact/footprint, member satisfaction and finances; this has been an expansive charge. At present there are many talking points and no consensus. Focus on the carbon footprint and how to best educate our Assembly Representatives as well as sharing this information with district branch membership and understanding its impact to the organization and informing decisions. There was a thoughtful discussion by Council members related to application of the foot print information to decisions for meetings, sustainability for the organization, planning for the future, fiscal health.

There was active discussion about the potential for nearby Area Councils to explore opportunities for collaboration (example Area 3 and 4)

Drs Chou, Dunlap, Albaugh and others discussed the importance of the APAPAC and the basics of the mission and working of the APAPAC Board. In 2023, Area 3 Council achieved 100% full participation with contributions to the APAPAC. The hope/plan is to sustain this effort year to year and pull the district branched into the process. The PAC helps to support all the APA Advocacy work with legislators.
